SCHOOL PLANT FACILITIES LEVY

Shall the Board of Trustees of School District No. 401 Teton County, Idaho, be authorized and empowered to levy a School Plant Facilities Reserve Fund Levy in the beginning amount of \$420,000, four hundred twenty thousand dollars, for the first (1st) fiscal year beginning July 1, 2016 and increasing thereafter in an amount of \$20,000 per year, for each of the next four (4) fiscal years, for the purpose of allowing the District to acquire, purchase or improve a school site or school sites; to build school facilities or other building or buildings; to demolish or remove school buildings; to add to, remodel or repair any existing building; to furnish and equip any building or buildings, including all technology, lighting, heating, ventilation and sanitation facilities and appliances necessary to maintain and operate the buildings of the district; to purchase school buses; and for lease and lease purchase agreements for any of the above purposes and to repay loans from commercial lending institutions extended to pay for the purchase or construction of school plant facilities.

SPECIAL ROAD & BRIDGE LEVY

Shall the Board of County Commissioners of Teton County Idaho be authorized to levy an override levy pursuant to Idaho Code § 63-802(3) and Idaho Code § 40-801, in the amount of up to \$1,000,000 per year for a period of two years, commencing with the fiscal year beginning Oct. 1, 2016, for the purpose of improving county infrastructure maintained by the Road and Bridge Departments of Teton County, and of the cities of Driggs, Victor and Teton, all as provided in the Resolution adopted by the Board of County Commissioners of Teton County on January 25, 2016.

- IN FAVOR OF authorizing the levy in the amount of \$1,000,000 per year for two years
- AGAINST authorizing the levy in the amount of \$1,000,000 per year for two years
